

## **Dependency Appeal Instructions**

Students classified as dependent by the FAFSA or CA Dream Act Application may appeal to be classified as independent based upon unusual circumstances that make obtaining your parents' financial aid application information impossible. Examples of unusual circumstances include abandonment by parents, an abusive family environment that threatens the student's health or safety, or student being unable to locate their parents.

None of the following conditions qualify: parents refusal to contribute to the student's education, parents unwillingness to provide information, parents not claiming the student as a dependent for income tax purposes, nor a student demonstrating total self-sufficiency.

1. Prepare the following requirements before submitting your appeal.

## New Dependency Appeal requirements

A) Write a statement that addresses the following:

- The extraordinary family circumstances led to you leaving your parents household
- Your past and present relationship with both of your parents
- How are you supporting yourself
- Describe and list the most recent date you had contact with or were supported by your parents

## B) Gather complete supporting documentation

• One letter of support from School or Community personnel who know your situation

## **Continuing Dependency Appeal Requirements**

Continuing SWC students who already have an approved appeal on file will only need to submit the appeal and upload a signed statement certifying that the situation remains the same as prior years (if this is the case). Third party documentation will not be required.



If you have not already done so you will need to set up access through the Jag Docs platform.

4. Once all documents are attached click the "Submit" and "Finish" buttons.
